TS District welcomes and supports your proposal for a collaboration with the objective of providing our schools with mental health support project for learners in Mamelodi and surrounding areas.

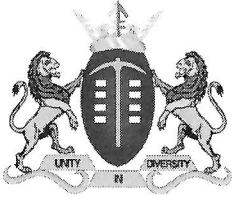
Permission is hereby granted to **Community Keepers** to approach schools with this proposal.
